Dear Sir/Madam,

We are Inviting Technical and commercial Bids on urgent basis for supply and installation of UPS Batteries (with buyback) - capacity 12V/100Ah(preferably Amaron Quanta) for various Offices located across Maharashtra and Goa regions on need basis as and when required during period of 6 months (till 30th Sept 2024) Battery Specification is attached herewith (annexure 2).

TERMS AND CONDITIONS OF THE TENDER

1. Eligibility Criteria:

The vendor must be an authorized distributor/dealer/partner of the OEM. The documentary proofs like Authorisation letter, GSTN Registration, TAN, PAN number, Details/Documents of Turnover for the previous two years are required to be submitted along with the technical bid. The offer must be made in Indian Rupees only.

Qualification norms of bidders shall be entirely at the discretion of the Tender Committee of the Company.

2. Payment Terms:

National Insurance Co. Ltd., will make 100% payment through NEFT/RTGS mode on successful supply & installation of batteries on submission of duly signed installation report of National officials at respective Offices.

2.1 For ensuring NEFT/RTGS payment, the service provider would complete all formalities in regard to payment through electronic mode.

2.2 The payment would be made after deducting necessary taxes applicable.

3. Delivery and Installation:

- The complete items ordered should be delivered and installed within One (1) week from the date of purchase order with coordination of branch office & with existing ups service engineer during installation of batteries.
- If the batteries are not delivered and installed by the mutually agreed date of delivery at the sites mentioned above, National reserves the right to cancel the purchase order.

- Proper Installation reports should be submitted in the branch office after installation of batteries indicating all necessary voltage parameters of batteries & UPS.
- Purchase/Buyback quantity of batteries may vary depending upon availability/requirement of batteries at respective offices. For tender purposes considering replacement of a complete set of batteries we are taking count as 20 numbers.

4. Warranty: minimum 24 months onsite warranty.

5. Penalty for Delay:

For any delay in installation and commissioning of the ordered items, NIC Limited will charge a penalty @ 0.5% of the order value per week or part thereof, subject to a maximum of 10%.

- Annexure 2 mentions whether all 19 points mentioned in annexure 2 are complied or not., deviations if any should also be mentioned, attach brochure if any.
